a) The Town/City name must reflect the actual geographical location of the service line's address. It appears that many of these addresses are in Brighton per the E9-1-1 Viewer (vermont.gov). Do not use the customer's Post Office assigned Town/Village/City name or the census-designated place (CDP) name.

b) Entries inputted between rows 317 and 332 have a Street Address of **Cottage Road** when E9-1-1 Viewer shows the street name to be **Cottage Dr**.

4) If **Other** is chosen for any required field, it must be accompanied by a comment in the Intro and Summary Table. The only exception is if the service line material is unknown, then the source used to determine line material should be **Other** and no comment is necessary.
