

SELECT BOARD MEETING MINUTES MARCH 17, 2021

Present: Michael Strait, Jeanne Gervais, Heather McElroy, Bruce Rumball-Petre, Paul Chambers, Joel Cope and Teresa DeBonville.

Chairperson, Michael Strait called the meeting to order at 6:01 PM.

Updates: None.

Public comment: None.

Road Department: The spouse of one of the road crew members has tested positive for covid-19. All worker's will be tested. The road crew worker has been told to quarantine.

Buildings and maintenance: Bruce informed the board about projects he has been working on, and those upcoming projects he plans to work on. (New billboard in hallway upstairs at the townhall, painting the basement and replacing baseboards, railroad depot bathroom floor project finished, etc.)

The board reviewed the two bids received for replacement of the depot furnace. Joel suggested having an energy audit done before replacing the furnace to see how efficient it is running. The board wanted estimates as a rough idea as how much money to put in the budget for when the time comes for this project to be done.

The billboard by the post office has been re-organized into two sections. One for public notices and one for municipal notices. The board agreed to have a policy in place stating that notices are allowed to be up for no longer than 30 days.

The ice rink has been closed for the season.

Paul will look over the park and start thinking of placement for the new work out equipment to be placed in the spring.

Appoint Mike and Jonah to CUD board: A motion was made by Heather McElroy to appoint Michael Strait and Jonah Rumball-Petre to the CUD board. Jeanne Gervais seconds the motion, all in favor, so carried.

Liquor licenses: A motion was made by Jeanne Gervais to sign the liquor license renewals for Kingdom Market, Gerardo's, The Hearth and Home and The Dollar General. Heather McElroy seconds the motion, all in favor, so carried.

Approve previous meeting minutes: The board reviewed the minutes of the March 3, 2021 meeting. A motion was made by Jeanne Gervais to accept the minutes as printed. Heather McElroy seconds the motion, all in favor, so carried.

Other business: the board discussed speed bumps and radar speed limit signs. Joel will price these out, and get back to the board.

Bruce will check on pricing for placement of the town logo on all town equipment.

The board talked about putting up the goose fencing early this year.
